APPLICABILITY

Applicable to any member of the Cooperative for dusk to dawn security lighting service, subject to the Cooperative's established service rules and regulations.

MONTHLY RATE

(A) Standard pendent style luminaries with 30-inch bracket on a wood pole. Standard shoebox style luminaires installed on a fiberglass pole with the appropriate bracket.

(B) Additional Charges:

The monthly rates shown under Section A are applicable where one additional 35-foot Class 5 wood pole for pendent style lights, or one additional fiberglass pole for Shoebox style lights, must be installed as part of providing service. If the consumer requests the security light to be installed in a location such that more than one additional wood pole is required, the consumer shall pay the Cooperative a Contribution-In-Aid of Construction equal to \$475 for each additional pole.

Decorative and/or non-standard poles and luminaries may be installed, at the Cooperative's option, at the monthly rate shown above for the equivalent wattage, plus either a Contribution-In-Aid of Construction or an additional monthly charge equal to 1.7% times the difference between the estimated installed cost of the luminary(ies) and structure requested and the estimated cost of the equivalent wattage luminary(ies) and a 35-foot Class 5 wood pole.

When the installation of underground conductors requires more than 200 feet of trenching and/or extraordinary trenching (i.e. pavement cutting and replacement, rock digging, or duct system) the member shall have the option of paying a Contribution-In-Aid of Construction or an extra monthly charge of 1.7% of the difference between the estimated extraordinary installation costs and the estimated installation cost for normal trenching.

CONDITIONS OF SERVICE

- 1. Luminaries will only be installed on Cooperative owned poles or structures. All facilities necessary for service under this Schedule, including fixtures, lamps, controls, poles, structures, hardware, conductors, and other appurtenances shall be owned and maintained by the Cooperative.
- 2. All maintenance, including lamp replacement, will be performed during regular business hours, as soon as possible, following notification by the member.
- 3. The member shall protect and be responsible for all deliberate or careless damage to the Cooperative's lighting equipment. The Cooperative reserves the right to cancel the rental contract if such damages occur and remove the luminary along with all property in connection therewith.
- 4. The member shall allow authorized representatives of the Cooperative to enter upon the member's property for required maintenance; to trim and cut trees and shrubbery as necessary for maintenance of the lighting equipment; and to remove lighting equipment upon termination of service under this Schedule.
- 5. Member shall be responsible for all costs to have the light relocated.
- 6. Service under this schedule contemplates continuous month-to-month use. A member who has service discontinued and then turned back on (other than for nonpayment of bill) within 12 months of the date service was discontinued, shall pay the applicable monthly rate for each month service was not being used.

CONTRACT PERIOD

At its discretion, the Cooperative may require a contract for service with an original term of three (3) years. After the original contract term, service may be terminated with 30 days' notice. Members terminating service prior to the end of the original contract term may be responsible for the Cooperative's costs to remove the facilities associated with service under this Schedule.

WHOLESALE POWER COST ADJUSTMENT CHARGE

The above kWh charges may be increased or decreased by 0.001 cents per kWh, or major fraction thereof, adjusted for line losses and North Carolina gross receipts taxes, by which the Cooperative's cost of purchased power, on a per kWh basis, exceeds or is less than the Cooperative's base cost of power, as prescribed in the Wholesale Power Cost Adjustment Rider.

TAXES

North Carolina Sales Tax will be added to the rate and shown on the bill.

TERMS OF PAYMENT

The above rates are net. Bills are due and payable within 25 days of the billing date shown on the bill. In the event the current monthly bill is not paid, it shall be considered delinquent, may be subject to a late fee, and service will be suspended in accordance with the Cooperative's established Service Rules and Regulations.
